If a client wishes to cancel the video, it must be done BEFORE one week of the wedding date. **Otherwise** 50% of the agreed package price will be due immediately, even if cancelled.

Miller Video Productions will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage.

It is the client's responsibility to secure access to areas for videography. *Miller Video Productions* will not be responsible for coverage lost due to access restrictions. *Miller Video Productions* will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics, poor lighting, poor sound systems, interference from guests, wireless microphone interference, rules of the venue, etc.

Creative aspects such as shooting and editing style are at the discretion of *Miller Video Productions*. *Miller Video Productions* also reserves the right to edit any obscenities or profanity from the final product.

Food should be provided at the reception for personnel of Miller Video Productions.

Miller Video Productions reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full, and assistance will be offered to find a replacement videographer.

Any liability on the part of Miller Video Productions will be limited to the amount of monies paid.

Upon taking possession of the finished product, the client must inform *Miller Video Productions* of any technical or other problems with the video within 7 days. After 7 days, if no notification has been received, the client will be deemed to be satisfied with the product.
